

# Enrollment for StationMD's I/DD-Specialized, 24/7 Virtual Service through the OhioISP



## Why Add the Service?

Adding StationMD to an Individual's ISP means providing immediate, expert medical care — anytime it's needed. This service helps close critical gaps in care, reduce unnecessary emergency room visits, and lower Medicaid costs.

More importantly, it prevents trauma from avoidable in-person interventions, supports medical stabilization, and allows individuals to remain in the community with fewer disruptions. Better health creates more opportunities — and that starts with better access.

## How to Add the Service

SSAs can authorize Health Care Assessment in the ISP. The service is billed at 1 unit per month, with each unit costing \$34.50.

The provider name to enter is: StationMD Professional Corp.

Enrollment is simple — identify the need, complete the ISP entry and PAWS enrollment, and StationMD takes care of the rest.

## Cost Savings

In Ohio, the average emergency room visit costs \$1,570 — not including transportation or staff time. Most ER trips pull DSPs away for at least 5 hours, costing agencies an additional \$90+ per event (not including overtime or emergency staffing).

By comparison, StationMD costs just **\$34.50 per month** — offering 24/7 medical support without the trauma, disruption, or delay.

## About StationMD

StationMD is a specialized medical service designed to address the unique healthcare needs of individuals with intellectual and developmental disabilities (I/DD), delivered through telemedicine. Our clinicians are board-certified professionals and specially-trained to provide exceptional I/DD community care.

StationMD's mission is to enhance the quality of life for individuals with I/DD and support their families and caregivers by delivering easy and dependable access to healthcare at any time.

As SSAs complete the newly required tools under the CMS Access Rule, any identified healthcare concerns can be addressed through StationMD. Our Health Care Assessment service offers immediate access to a clinician specially trained in caring for individuals with I/DD, who can assess and treat in real time. Enrollment is simple and covered by the individual's waiver.

## 1. Adding the Service

An assessed need must be identified in the ISP. SSAs will add StationMD to the OhioISP as a Health Care Assessment service and support.

The service is one unit per month for each month of their span at \$34.50 per unit. Access to StationMD lasts the full term of their span.

\* SSAs / providers to ensure individual has equipment and internet to use service.

## 2. Complete the Cost-Projection Tool

The county board, SSA, or other county board staff must complete the cost-projection tool for the Health Care Assessment service using the following codes:

- Individual Options Waiver (Code: AAS)
- SELF Waiver (Code: SAS)
- Level One Waiver (Code: FAS)



## 3. Complete Medical Information Packet

Once an individual (and/or their guardian) has StationMD authorized in their waiver, [the medical information packet linked here](#).

Please ensure the individual's support team is together to fill this out as birthdate, insurance information, medications, and medical history are part of this packet.

The individual's Service and Support Administrator (SSA) must complete the free choice of provider process for the service.

\*Medical info packet not required for those previously enrolled at any time during Ohio pilot.

## 4. Once an individual is enrolled with StationMD, the service is effective IMMEDIATELY.
